LAND GOVERNANCE COMMUNITY PROFILE FORM

The [Framework Agreement on First Nation Land Management](#) (Framework Agreement) is a government-to-government agreement for signatory First Nations to opt out of the 33 lands related sections of the *Indian Act* and to replace those sections with their own legal framework, referred to as a land code. First Nations who become operational under their own land code take on full law-making authority and administration of their reserve lands, environment, and natural resources. The Framework Agreement recognizes First Nations' inherent right to govern their lands. Funding is available to support First Nations who are signatories to the Framework Agreement and are engaged in the activities of the developmental or operational phases of implementation.

This form has been jointly prepared by the Lands Advisory Board (LAB), First Nation Land Management Resource Centre (Resource Centre) and the Government of Canada as a tool to assist:

1. First Nations in reflecting on community drivers and other important considerations in developing and implementing a land code;
2. the Resource Centre in assisting with land code development and implementation support; and
3. Canada in allocating pre-capacity, capacity, and developmental funding.

The responses provided in this form will promote greater understanding of each First Nations' unique situation, planning in the developmental phase and will help utilize capacity investments to maximize benefit.
